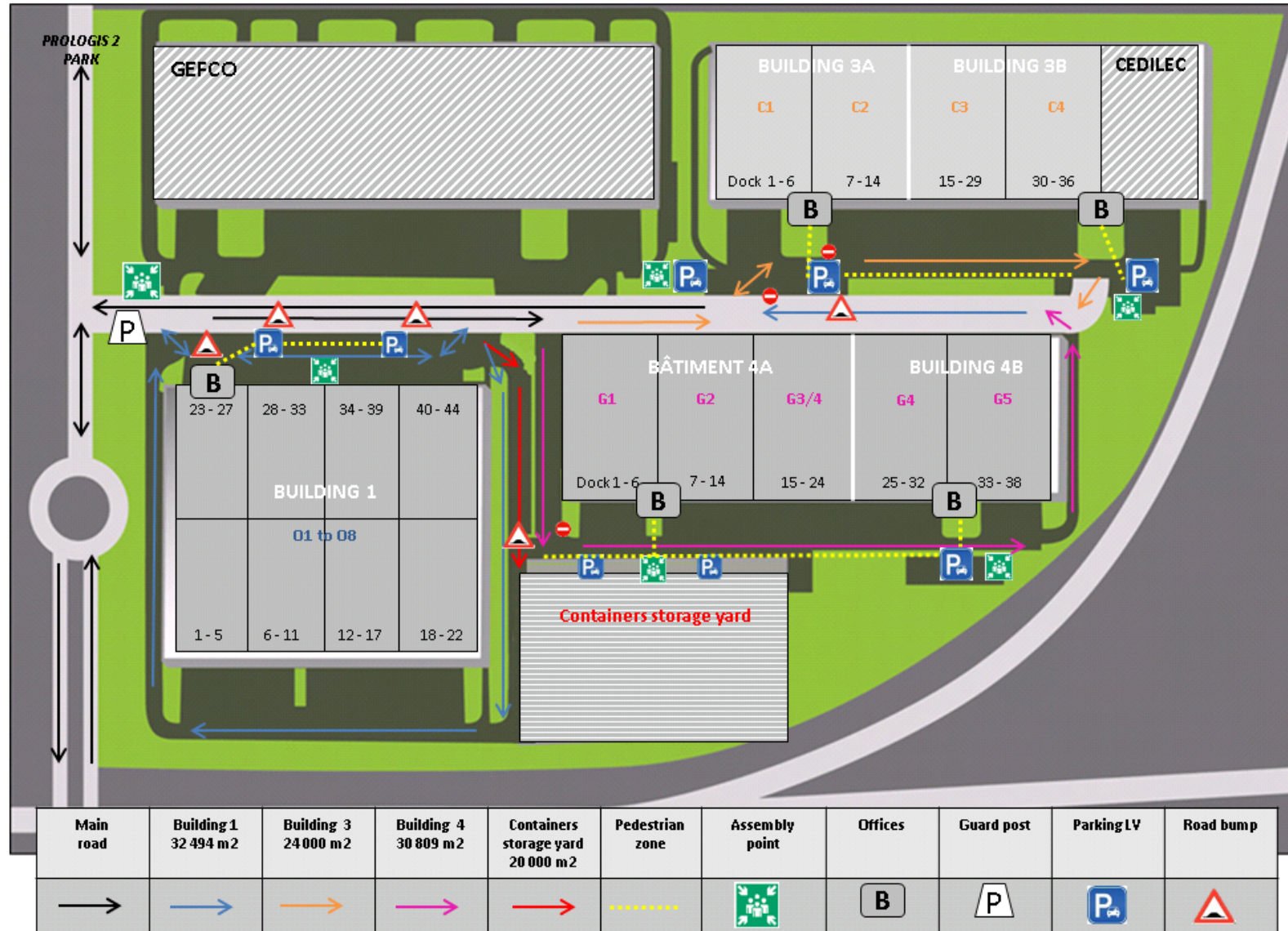

XP LOG PLAN - PROLOGIS PARK – PORT 5515

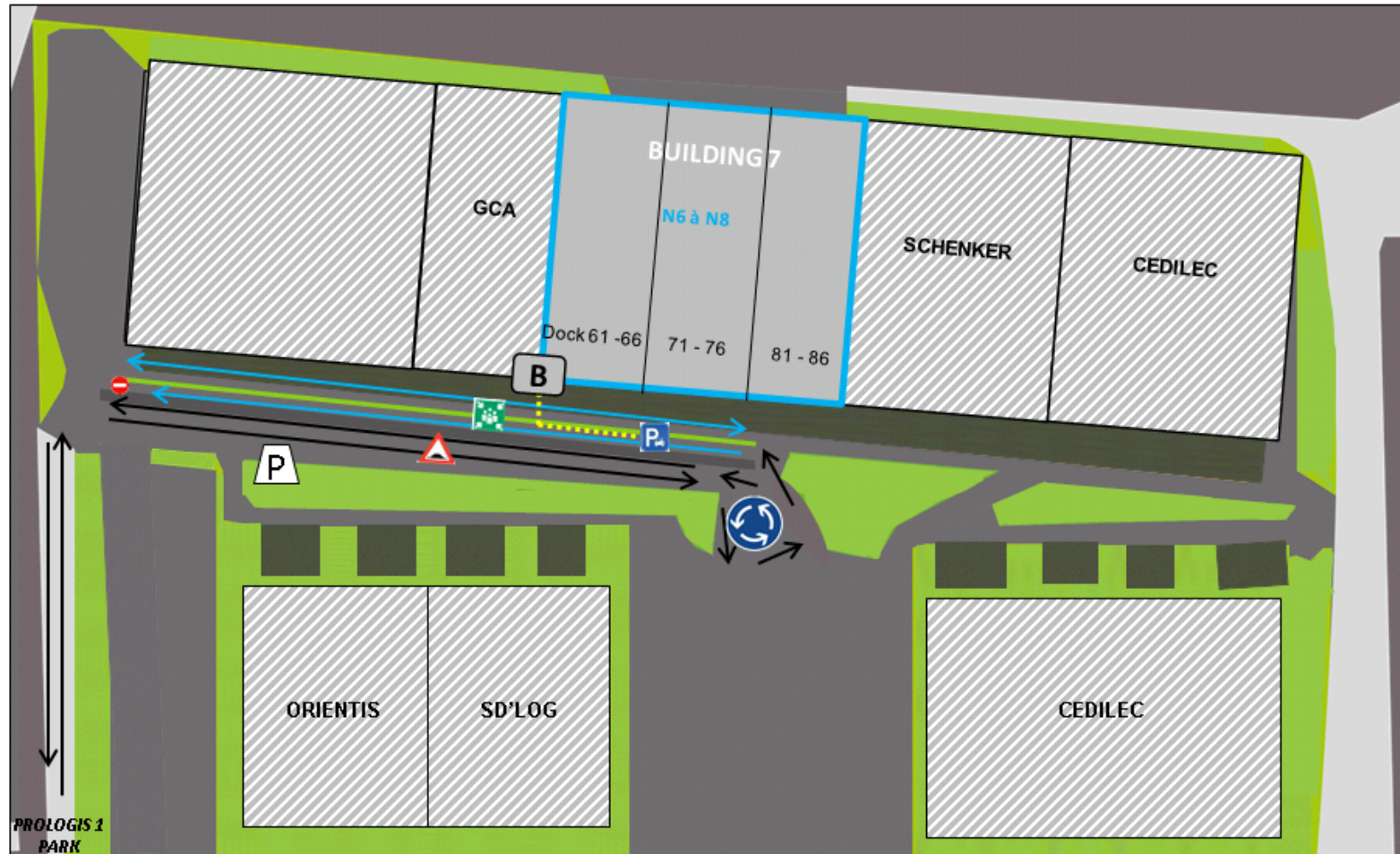
